In recent weeks SWAN members have participated in several events conducted by **local First Nations groups**. This includes the **Reconciliation Week** Walk at Willum Warrain Aboriginal Gathering Place, Hastings on Sunday 29 May. During **NAIDOC Week** (3-10 July) SWAN was represented at Flag Raising ceremonies at Willum Warrain and Nairm Marr Djambana Aboriginal Gathering Place. We were also invited to join in the Native Tree Planting event that was organised by Our Songlines in Main Ridge.

We have slightly amended the **SWAN Position Paper on an Indigenous Voice** that was circulated to SWAN members last month. This reflects the commitment made by the new government to holding a Referendum on the Constitutional Enshrinement of an Indigenous Voice in its first term. The revised version is on the SWAN website and circulated to local media and selected community organisations: <u>https://swanwomen.org.au/</u> Please share it in your own networks.

In late May SFN member Maureen Donelly wrote to MPSC to enquire as to whether the new **Peninsula Trail will reference First Nations cultural heritage** and seek clarification of who is involved in the planning. She recently received a response from the Council Project Coordinator to confirm that the Shire is working to formalise an arrangement with the Bunurong Land Council (BLC), that will ensure First Nations cultural heritage and history is included in Peninsula Trail signage. The first stage of this engagement with the BLC will see Council officers working with the BLC to identify appropriate signage and/or other cultural interpretation features for the Somerville to Baxter section of the Peninsula Trail. First Nations, cultural heritage and history will also be incorporated in the remaining sections of the Peninsula Trail in conjunction with the BLC as those sections develop.

The SWAN Committee recently approved a letter written by some SFN members to the Victorian Government expressing concern about the government's decision to delay the introduction of vital, long overdue legislation that aims to reduce youth offending and to protect the rights and wellbeing of vulnerable First Nations children. Of particular concern – we ask that the Andrews government **raise the age of criminalisation** from 10 to 14 years. A copy of this letter is attached below. Position Paper re the Constitutional Enshrinement of an Indigenous Voiceⁱ

Our country is facing a critical moment in our history. There is significant unfinished business to address. 'The Uluru Statement from the Heart' (2017) gifted by First Nations Peoples to all Australians guides the way. It invites us to walk alongside Aboriginal and Torres Strait Islander Peoples to create an equitable future for us all.

The Southern Women's Action Network (SWAN) comprising over 200 members across the Mornington Peninsula accepts this historic proposal as originally formulated and requested by First Nations Peoples. We strongly support its call for lasting systemic change through the Enshrinement of an Indigenous Voice in the Australian Constitution. Furthermore, we support the establishment of a Makarrata Commission to oversee a process of Agreement-making between governments and First Nations and Truth-Telling about our history. These reforms are practical and just. They are long overdue. In March 2021 we documented our position on constitutional protection in a submission to the Indigenous Voice Co-design process commissioned by the Minister for Indigenous Australians, Ken Wyatt. We expressed our concern that Australia lags well behind other countries in upholding the key principles of The United Nations Declaration on the Rights of Indigenous Peoples. First Nations Peoples in this country do not have "autonomy or self-government in matters relating to their internal and local affairs".ⁱⁱ

Our proposal was amongst the 90% of submissions received from over 9,400 people, communities and organisations to disregard the government's requirement that respondents restrict any recommendations to mere *legislative* change. We argued that matters dealt with by *legislation* alone can too readily be amended or eliminated. This will not ensure that the concerns of Aboriginal and Torres Strait Islander Peoples are addressed. Moreover, *legislating a voice* prior to the nation endorsing a constitutionally protected First Nations Voice to Parliament will not achieve the long-lasting systemic change that is required. Constitutional protection would ensure that any significant alterations concerning the First Nations Voice would need to be passed by Referendum.

SWAN applauds the commitment made by Prime Minister Anthony Albanese in his election speech (May 2022) to implement The Uluru Statement from the Heart - in full and support his pledge to hold a referendum to Constitutionally Enshrine an Indigenous Voice to Parliament.

When enacted, this will ensure that our Constitution is amended in line with international standards on the rights of Indigenous Peoples. This will guarantee that Aboriginal and Torres Strait Islander Peoples have a lasting say in the laws and policies that affect their lives and lead to better policies and outcomes for their communities. It will profoundly enhance government capacity in Indigenous affairs policy development and law-making.

Bipartisan support is critical for such a Referendum to succeed. All Australians must be well informed before they cast their vote. SWAN is contributing to this advocacy and

education process. Our members are actively sharing information in their communities and political forums about why a decision to proclaim a First Nations Voice to Parliament enshrined in the Australian Constitution is so crucial for the future of our nation.

Dear Premier,

The Southern Women's Action Network (SWAN) comprising over 200 members across the Mornington Peninsula has advocated for social justice for over 25 years. Our members are actively engaged in addressing a broad range of human rights concerns both locally and at a national level. We have a strong commitment to supporting the rights of First Nations Peoples.

I write on behalf of the SWAN Committee and our Supporting First Nations group to acknowledge the important steps that you have taken to begin to address the structural injustices in Victoria's youth justice system, especially with respect to Aboriginal children and youth. The recommendations documented in two comprehensive, independent reviews¹ commissioned by your government clearly identify the systemic, legislative and program level reforms that are long overdue. These recommendations must be implemented without delay.

We acknowledge that some important initiatives have been taken. Your proposed new law entitled 'The Children and Health Legislation Amendment Bill 2022' aims to ensure that fewer Aboriginal children are separated from their families. However, we are deeply concerned that debate on a second piece of legislation to protect the rights and wellbeing of vulnerable First Nations children has been delayed until after the November Election. I refer to 'The Children's, Youth and Families Amendment (Child Protection) Bill 2021' that would address systemic injustices related to youth offending and would raise the age of criminal responsibility to 14 years.

Your decision to postpone debate on this Bill that was passed in the Legislative Assembly last year is not in line with your government's election commitment to urgently address systemic problems in the youth justice system. Moreover, it is at odds with your

government's strong rhetoric that it will tackle discrimination against First Nations Peoples.

It is critical that legislation be introduced immediately to:

- Raise the age of criminal responsibility to at least 14 years without exception. This complies with the recommendation made by the UN Committee on the Rights of the Child (2019)². This higher age level is already law in over 30 other countries and aligns with the commitments made by the ACT, Tasmania, South Australia and the Northern Territory.
- 2. Address the over representation of First Nations children in our youth justice system. Your 2021 Review found that despite some valuable initiatives that have been undertaken the current laws continue to 'disproportionately harm Aboriginal children... (who) are targeted by the police, sentenced by the courts, and removed from their families and communities.'³ It is essential that resourcing and access of preventative programs and therapeutic services be significantly increased. These must be age and culturally appropriate and targeted to help Aboriginal children and youth stay outside the criminal legal system altogether.

You now have the opportunity to legislate these vital, long-awaited reforms. 'The Children's, Youth and Families Amendment (Child Protection) Bill' was tabled in the Upper House more than 8 months ago. It is supported by the Coalition and the Greens⁴. We urge you to show strong leadership by reintroducing it without further delay to allow it to be ratified by the Senate. The Victorian electorate will commend such progressive action to enact these critical reforms.
