Micaela Cronin appointed as Australia's first Domestic Family and Sexual Violence Commissioner

In May 2019, Micaela Cronin, Director of the Future Social Services Institute spoke to SWAN about her long-term work in the not-for-profit community sector, including as CEO of Hagar International based in Cambodia and as President of ACOSS. Micaela will begin at the newly established commission in early November. She will act as an advocate for victim-survivors and be responsible for reviewing the progress of the national plan to end violence against women and children.

Progress! Women in Justice!

In a history-making decision, the High Court of Australia will be dominated by female justices, with the appointment of Jayne Jaogot to the bench. For the first time in history, there will be more females than males on the High Court bench! We also recently reported on the appointment of the first Aboriginal High Court judge, Lincoln Crowley.

"Budget of failed expectations" says Asylum Seeker Resource Centre (ASRC)

The 2022-23 Federal Budget failed to live up to the public expectations for a more compassionate and fair country for refugees and people seeking asylum. ASRC is deeply disappointed that key Australian Labor Party commitments have not been met in this budget, including increasing humanitarian intake, abolishing Temporary Protection Visas/Safe Haven Enterprise Visas and providing appropriate social services for people seeking asylum. This highlights the need for the Albanese Government to meet the public's expectations, its election promises and repair the damage done over the previous decade in the May 2023-24 budget.

Expectations failed:

- No increase in social support for people seeking asylum
- No increase in the humanitarian intake
- Increase spending on offshore and onshore detention
- Lack of needed reform to address refugee visa backlog

The Budget did commit new funds to speed up visa processing, and funding for women on temporary visas facing domestic and family violence increased.

UPDATE RE SWAN HISTORY PROJECT, NOVEMBER 2022

In the October edition of SWAN News, we told you about the progress made so far on the SWAN History Project. Here is a further update on the work that has been done so far and what's planned in the lead up to our 2023 International Women's Day meeting that is scheduled to be held on **19 March.**

In recent months a small working team comprising Judith Galey, Diane McDonald and Moz Lucas has collected contributions from a dozen or so SWAN members from across the different eras. Some insightful feedback about 'their SWAN experience' has also been received from several former guest speakers. In addition, we have compiled information about many of the young women who were awarded a SWAN Bursary, including some comments on how this encouraged them to pursue social justice-oriented career paths.

With assistance from several other SWAN members, including Erica Churchill, Vivienne Daniels and Lesley Beasley (just to name a few), we are presently reviewing archival files and newsletters (from 2000 onwards) to collate information about key events and find good photos.

We also want to acknowledge the many other SWAN members who have so generously responded to our requests for written summaries about specific actions undertaken by SWAN on a broad range of social justice issues including domestic violence, refugees and asylum seekers, racism, supporting First Nations, as well as activities that have been facilitated to help strengthen the political awareness and media engagement capability of women on the Mornington peninsula.

Once we have collected all this material, we plan to publish it the form of a small 'booklet' that will be launched at our International Women's Day meeting in March. Our guest speaker will be Jean Ker-Walsh who has extensive experience in facilitating groups that are engaged in community based social action. This will be an important occasion for us to celebrate the past and to dream about SWAN's future, exploring how SWAN can be further developed to ensure that it continues to involve and inspire women in the current context.

SUPPORTING FIRST NATIONS

Voice, Treaty and Truth-telling

MEETING with Federal Government MP for Flinders Electorate, Zoe McKenzie.

Recently Erica Churchill, Moz Lucas and Diane McDonald had a very productive half hour meeting with Federal MP for Flinders, Zoe McKenzie (via the electronic communications platform 'MS TEAMS'). The purpose was to introduce SWAN and to hear Zoe's views on the Uluru Statement from the Heart, and in particular, the Enshrinement of an Indigenous Voice to Parliament. Zoe has prior knowledge of issues associated with constitutional change having been a legal advisor during the Referendum on the Republic (1999). She has also worked on Indigenous Policy making.

Zoe plans to meet with local First Nations groups to hear their views on the Uluru Statement from the Heart and the upcoming Referendum on an Indigenous Voice to Parliament. She is also keen to hear the views being expressed by her broader constituency. Zoe has yet to form her own opinion on these reforms and looks forward to more detailed information being released by government over the coming months. She emphasised her sense of responsibility in this important history-making process stating that *'The time has come for getting it right'*, so that Indigenous Australia is not left behind yet again.

Zoe has already visited Willum Warrain and would appreciate SWAN's assistance to connect with other First Nations groups. She would also be interested in liaising with SWAN once the Community Education campaign begins in the lead up to the Referendum.

RECONCILIATION VICTORIA: Survey of Victorian Election Candidates views on Voice, Treaty and Truth

The research findings show that 33% of the 234 Victorian Lower House candidates and MPs who were invited to participate in this survey, responded. The greatest number of responses was received from candidates in Kororoit, Shepparton, Northcote, Hawthorn and Brighton. No response was received from Hastings. Responses were also received from candidates in seven of the eight Legislative Council regions. But no candidate from the South-Eastern Metropolitan region (that includes Frankston district) and only one candidate from Eastern Victoria (that includes the district of Mornington) replied.

The key findings show that support for the Uluru Statement from the Heart and a constitutionally enshrined Voice to Parliament was high, with 86% and 85% of candidates respectively agreeing they/their party supports items. Notably, many Liberal and National Party candidates indicated a neutral stance (neither agree nor disagree) however. A MESSAGE for First Nations allies from 'The Track to Treaty in Victoria' webinar (10/10/22)

First Nations speakers, including Sue-Anne Hunter, Commissioner from the Yoorrook Justice Commission, urged non-Indigenous allies as 'the other 97%' to back the Victorian Treaty process and stressed that allyship is absolutely necessary for Treaty success for Victoria.

Some heart-wrenching truths captured in the Yoorrook Justice Commission Interim Report (June 2022)

'Mummy's eldest sister, Aunty Ruby Muir ... did not know the full story about why she was adopted into our family until she was dying in her 90s, when she was living in a nursing home in Mooroopna. For her entire life, Aunty Ruby believed that she was sent to Cummeragunja because her mother had given her away. On her deathbed, she was asking, "why did my mother give me away?" [We] found out that there had been a massacre of Aunty Ruby's family in Barkindji country, near Mildura. Aunty Ruby, Uncle Charlie and Uncle Billy were found in a water tank. The whole family had been massacred. The children were hidden in the empty water tank, to protect them. The welfare or whoever at the time gathered

up the children and put them onto a paddle-steamer, and the children were brought down to Cummeragunja. 'Aunty Fay Carter (page 26).

'I was taken from my Mum and placed in a series of homes to be raised as a white person. Nobody every taught me love. I was never raised in a loving situation, never held. I can't remember ever being held as a child, as a baby.' Uncle Jack Charles (page 27).

Youth Justice, Systemic Racism and Climate Change

A LEADER IN REFORM

The United Nations and 33 of its member states have challenged Australia to raise the age of criminal responsibility - currently 10 years of age! The Northern Territory Government is taking the lead, currently putting forward legislation to raise the age to 12. And once a network of alternative systems and support services have been stepped through and expanded, raising the age further to 14 or higher. Tune into ABC's Radio National (RN) program 'SPEAKING OUT' broadcast by First Nations' woman Larissa Behrendt speaking with Chansey Paech, First Nations man and the NT's Attorney General and Minister for Justice leading the way on this much awaited key reform. Chansey also addresses questions about family and domestic violence and sexual violence, as well as the current Northern Territory Treaty process in relation to the Uluru Statement from the Heart.

A RECONCILIATION ACTION Plan Update from Mornington Shire Council

We have recently been able to establish that the officer who is responsible for the Reconciliation Action Plan co-ordination is Julia Young, Mornington Peninsula Cultural Heritage Advisor. This role is very broad with First Nations culture and heritage being just one part, alongside responsibility for the many historical societies in the shire. The role also includes, as you would expect, liaison with Willum Warrain Aboriginal Association and Bunurong Land Council (BLC). Julia is not indigenous herself. She acknowledges that the Warringinee team's cessation has left a gap and may be open to recommending a dedicated Council Aboriginal Liaison position.
