Judith Graley MP Founding Member of SWAN


We are delighted to welcome Judith Graley as our guest speaker this month. As a founding member of SWAN, we have much for which to thank her. Furthermore, Judith has occupied a number of roles serving her community, initially through her roles in a range of educational settings, through various positions in local government to her current position as the MLA for Narre Warren South and Parliamentary Secretary to the Leader of the Opposition since February 2012.

Judith lives locally and is married with 2 daughters and a son.

As a qualified teacher, Judith has taught at both High Schools and at the University of Melbourne. She has been a board member of Peninsula Health, an Electorate Officer, a councillor on Mornington Peninsula Shire Council for both Kangerong and Mt Martha wards, the Mayor of Mornington Peninsula Shire

Council (2000-2001) and is currently serving her community as a Member of the Legislative Assembly, a position she has held since 2006. Hers is a history of vision, concern for others and action.

Dr Caroline Norma Challenging our thinking on Prostitution

Dr Caroline Norma set out to critique the Government's legalisation of prostitution in Australia, and introduce us to what she believes is a superior policy adopted in 1999 by the Swedish Government and subsequently by Korea, Norway and Iceland.

The Australian approach to the legalisation of prostitution is philosophically underpinned by the concept of harm minimisation. Harm minimisation is a policy approach that purports to protect prostituted women from male violence, the public from sexually transmitted diseases, and the community from organised crime.

She referred to a small amount of empirical evidence that significant numbers of sex workers in brothels are pressured to accept unprotected sex and physical violence, suggesting problems with the current policy. She hinted at the Government's inability to deal with street prostitution.

Whilst acknowledging that the Governments approach is a sincere effort "to make the best of a bad situation", Dr Norma aimed to convince us that the focus needed to change. She strongly advocated closer investigation of a more human rights oriented approach as exists in the Scandanavian counties - "Criminalisation of buyers of prostituted people, decriminalisation of prostituted people as victims of crime and public education as to human rights violation of prostitution." She cited figures of a decrease in the rate of "Swedish men buying women" and a "cut by half in street based prostitution."

Letter from Margaret James Scholarship Secretary Graduate Women of Victoria

"You will be interested to hear that Penny Scott, our 2013 Bursary winner, has let GWV know that she received an H1 for her research project on youth wages and that it is likely to be published by Melbourne University's Centre for Employment Law and Labour Relations in their student working paper series. Penny plans to continue studying for another 6 months. Many thanks from GWV to SWAN members for your interest and support."

SWAN has sponsored Indigenous bursaries for 3 years. However, in 2013 only 3 applicants identified as Indigenous, Penny being the outstanding candidate, and worthy of support.

For 2014, Marilyn Godley has very generously offered to donate \$5000 for a scholarship for an Indigenous student. As GWV now have a valuable scholarship for an Indigenous student, SWAN members need to consider whether we would prefer to continue with the Indigenous Bursary, or support a bursary in the general program for disadvantaged students.

From my own attendance at the Scholarship Presentation Days, I am well aware of the manner in which so many of the most impressive winners have overcome the disadvantages to their study from low income, disability, family responsibilities and so on.
